



Hanalei Canoe Club Membership Agreement

Hanalei Canoe Club is dedicated to perpetuating the culture and sport of Hawaiian Outrigger Canoe paddling with aloha. This mission entails more than simply paddling and paying one's dues, but also imposes certain obligations and responsibilities on all members. To ensure that the club upholds this broader vision and continues as a valuable part of our community, members are expected to follow the HCC Guidelines and the Club's Code of Conduct, adhere to the Club Rules, and agree to the Terms of Membership set out in this Agreement.

Code of Conduct:

- Treat other club members, coaches, and the general community with respect, honesty, fairness, and aloha.
- Treat club canoes, equipment, and property with care and respect.
- Strive to achieve one's personal best both physically and mentally and support others in doing the same.
- Place the best interests of the club and one's crew before your personal aspirations.
- Participate in and support all club events, fundraisers, and workdays and assist fellow members to the best of one's ability.
- Actively participate in practices and races as directed by the coaches.
- Follow all safety protocols (such as those for COVID) and requirements adopted by the Club.

Club Rules:

- Pay dues on time.
- Alcohol is prohibited on canoe club property except during certain sanctioned club events. Illegal drug use is not allowed on canoe club property at any time. Smoking is not allowed on club property at any time.
- Use of club facilities and equipment requires caution and care and is restricted to Active Club members and their authorized guests.
- Club members are responsible for any guests brought on the club property or using club equipment. This responsibility includes ensuring that one's guest(s) sign an HCRA waiver and pays an insurance fee prior to participating in any club practice or workout, or otherwise using any club equipment.
- Subject to space availability, personal OC1's or other watercraft may only be stored at the club after completing the HCC OC-1 Storage Policy & Agreement Form, and payment of an annual storage fee.
- All animals brought to the club must be under the control of their owner at all times, and the owner shall clean up after their pet.

Terms of Membership:

- I recognize that paddling is a physically demanding activity and I agree that I participate in practices and races at my own risk.
- I attest that I can swim 200 yards unassisted and tread water for ten minutes, or that I will wear an approved flotation device whenever paddling in a Club canoe. I understand that I may be required to demonstrate this ability.
- I will not hold Hanalei Hawaiian Civic Club, Hanalei Canoe Club, and/or the property owners responsible for injury or damage while on the canoe club property or arising from the use of any equipment owned or used by the canoe club.
- I agree to abide by the Constitution and By-Laws of the Hanalei Hawaiian Civic Club and the Guidelines of the Hanalei Canoe Club. (Copies of these documents are available upon request.)

By signing below, I acknowledge that I have read this Membership Agreement and agree to abide by it, and I acknowledge that violation of any part of this Agreement may result in my expulsion from the club and loss of membership privileges and any dues paid.
